GEOG 432 is an exploration of the government, corporate, and public perspectives on the analysis, development, and implementation of energy- and climate-related policies, regulations, and initiatives with particular emphasis on their climate change implications.

- Unit 1: we build foundational knowledge about the context of energy policy as climate policy and learn more about our semester-long project in energy efficiency.
- Unit 2: we dig into the nuts and bolts of how policy ideas become realities, primarily in the public policy spheres of local, state, and federal governments, and continue to work on the final project.
- Unit 3: we look ahead to our future. Recognizing that we're undertaking this course during a presidential administration transition, a lot of the detail for this last unit will be emerging in real time.

## What I Expect of You

On average, most students spend eight to ten hours per week working on course assignments. Your workload may be more or less depending on your study habits and pre-existing knowledge. If you stick to our schedule and stay connected and engaged, you're going to be successful in this class.

## Course Goals and Outcomes

At the successful completion of this course, you will be able to:

- **Identify** energy and climate policy knowledge gaps and needs at various governmental and entity levels.
- **Examine** existing and proposed energy and climate policy critically to expose errors, find unintended consequences, and contemplate improvements.
- **Identify** the drivers of energy and climate policy from political, environmental, and economic perspectives to explain how these drivers exist either in conflict with or complement each other.
- **Articulate** the goals and outcomes of energy and climate policy to diverse audiences, translating often-cumbersome language into a more accessible format for stakeholders and the public.

Specific learning objectives for each lesson and project are detailed within each lesson. The class schedule is published on the Canvas Calendar. Assigned readings are included in the Canvas modules.

**Course Policies**

**What should I do if I’m having trouble in Canvas when I’m trying to submit work or take a quiz?**

Technology only fails you when you need it most. Waiting until the very last minute to submit something invites technical issues that cost you a late penalty. Part of your responsibility in this class to ensure that your work is *received* by the deadline (not simply that it’s done by then).

- Take screen captures or pictures of the errors you’re receiving
- Email instructor right away
- If you’re trying to submit something to a drop box and it’s not working, email it to the instructor to demonstrate you had the work done by the deadline.

**Late Policy**

You are expected to submit your work on time, as scheduled; however, late completions are possible if arranged beforehand in the case of illness or emergency. **If you find yourself falling behind, talk to the instructor before\* you miss a deadline, not after.** Instructors are people too, and we understand that life

happens. Late submissions of any kind incur 10% per day penalty\*\* up to 5 days, **after 5 days no credit is received unless approved by the instructor.**

\*"Before" the deadline implies at least 24 hours' notice, except for extenuating circumstances that don't allow for that. Emailing 2 hours before the deadline to say, "I've been sick all week, can I have an extension?" doesn't work well. Be proactive in reaching out when trouble emerges.

\*\***Work due in the last week of the semester is NOT eligible for late submission with penalty.** If it is not submitted by the deadline a zero is recorded.

## **Academic Integrity – this is a big one!**

Academic integrity includes "a commitment not to engage in or tolerate acts of falsification, misrepresentation, or deception." In particular, the University defines plagiarism as "the fabrication of information and citations; submitting others' work from professional journals, books, articles, and papers; submission of other students' papers, lab results or project reports and representing the work as

In this course, you are provided multiple resources from the outset to understand how to properly cite your work, incorporate sources into your own writing, and attribute accordingly. There is no tolerance for disregard for these conventions. For example, you can't copy someone's words directly and just put a citation after it. That's not enough. First offenses carry a zero on the assignment sanction if found responsible, and it goes up from there. Saying you didn't know it was wrong is not a viable excuse, I just told you it was wrong.
